# **10. Appendix**

**Aerospace Medicine Residency and Master of Science Programs** at Wright State University (WSU) were conceived in 1978, making it the oldest active civilian aerospace medicine training program for physicians in the United States.

Our mission is to become the global leader of aerospace medicine education by setting new standards for aerospace education. During 2015, these efforts have continued with a strong focus on the quality of residents and students who enter our program, the educational products of the division, as well as a continued effort to provide community education and outreach. Our goal continues to provide a fully accredited Accreditation Council for Graduate Medical Education (ACGME) environment conducive to promoting clinical and scientific inquiry while providing the skills, knowledge, and competencies necessary to become a successful practitioner of aerospace medicine.

The residency and Masters programs have attracted and trained physicians with a wide variety of prior clinical experiences; Internal Medicine, Family Practice, Emergency Medicine, General Surgery, Pathology, Radiation Oncology, Nuclear Medicine, Infectious Diseases. Gastroenterology, Cardiology, Psychiatry, Neurosurgery, and Obstetrics/Gynecology. Through 2015, we have trained 164 physicians. This includes 84 residents as well as Masters Students consisting of United States military residents and physicians from other nations. Over the course of our history, the program has graduated more than 65 physicians from other nations around the world (Australia, Brazil, Canada, China, Colombia, Ethiopia, Germany, Greece, India, Iraq, Israel, Japan, Jordan, Kuwait, Mexico, Pakistan, Portugal, Qatar, South Africa, South Korea, Saudi Arabia, Singapore, Sudan, Taiwan, Thailand, The People's Republic of Congo, and the United Arab Emirates).

Trained physicians who are U.S. citizens engage in active careers with National Aeronautics and Space Administration (NASA), the Federal Aviation Administration (FAA), the United States Air Force (USAF), the Air National Guard (ANG), scientific labs, and academia. More than half the residency trained graduates at any given point of time in their careers, have been, or are currently employed by either NASA or its contractors. International graduates typically have been working for their governments or airlines and have been very successful in their careers, holding high-ranking positions of responsibility in their individual countries. By training an international cadre of Aerospace Medicine specialists, the program has been integral in the global advancement of the field of Aerospace Medicine as well as contributing to nation building.

To date we have graduated a total of 164 students; 84 residents and 80 MS students. Our overall graduation rate is 164/186 or 88.2%. Our overall graduation rate for MS students is 80/85 or 94.1%; and for residents is 84/101 or 83.1%. During this period 95 graduates (83 residents plus 12 MS students who were U.S. military residents) were identified as being Board eligible. Overall, 72/96 (>75%) Board eligible graduates have been certified by the American Board of Preventive Medicine (ABPM) or the American Osteopathic Board of Preventive Medicine (AOBPM).

During the 2015 calendar year, the program graduated three MS students. One new resident was recruited, along with an additional ten MS students.

Aerospace Medicine Residency Program

- This year the division launched the Aeromedical Transport Operations track within the residency. Residents in this track participate in Emergency Department patient care with additional duties of aeromedical transport management and quality improvement as a review committee member. For this track, new rotations are being developed at several locations: Cleveland Clinic Critical Care Transport, The Ohio State University Emergency Medicine Services, and the Civil Aeromedical Center at Bangkok Hospital, Bangkok, Thailand. The resident's E.D. activities provides a self-funding stream for the new track. This year, Dr. Arpan Kothari (see below) is the first resident to participate in this new track.
- Our in-house rotation for visiting residents and medical students has begun to pay

dividends. This year we recruited two well qualified residents, both of whom participated in the in-house rotation during 2014. Both residents come directly from a prior medical residency. Dr. Eric Fine graduated from Geisinger Family Practice Residency, Wyoming Valley Medical Center, Wilkes-Barre, Pennsylvania and Dr. Arpan Kothari graduated from Emergency Medicine Residency, Oakwood Southshore Medical Center, Trenton, Michigan after completing a fourth year as a Chief Resident. As well, several prospective candidates from the 2014 rotation have continued to maintain communications with our division, one spending additional time in our division.

- An elective rotation, for residents who are Air National Guardsman (ANG), has been added. The rotation is focused on national management of the ANG personnel and involves residents spending time at ANG headquarters in Washington, D.C.
- Resident flight training has continued with new experiences in tail wheeled aircraft and open cockpit aircraft. Both Dr. Fine and Dr. Kothari participated in flying activities at Red Stewart Airport in Waynesville, Ohio, where both experienced flying in a 1932 Steerman biplane. This is again in line with our goal of being a leader in aerospace medicine education.

Aerospace Medicine Master's Degree Program

- The new curriculum implemented in 2014, has generated excellent results as well as positive feedback from participating students. It has become apparent in the aerospace medicine community that students who graduate from our program come out with an excellent education. This feedback has been conveyed to us through multiple channels, including the USAF RAMs. Recent graduates who have sat for the Preventive Medicine board exam have scored in the top 25% of all takers.
- The curriculum's modular format was well appreciated by many of our international students, who desire two years plus in education duration as it translates into increased qualifications when returning to their home countries. This has allowed for two didactic tracks to be offered to incoming students, a one year track, and a two year track.
- The requirement for a Master's Project completion for graduation has undergone further growth. Students now have the additional option of preparing a research proposal according to National Institutes of Health (NIH) guidelines. This is felt to prepare future researchers with ample experience for potential future research grant submissions.
- Students continued to receive instruction for preparation of the FAA Fundamentals of Instruction (FOI) test. Upon test completion, the student is designated as an FAA ground instructor. This year, six students passed the FOI exam and received their ground instructor certificate.
- The division, for the second year, participated in a NASA/USN/WSU ASM educational video teleconference focused on space related medical issues as presented by space medicine specialists. The topics covered included: Bone loss in microgravity, the Longitudinal Study of Astronaut Health, Cardiovascular Effects of Space Flight, Operational Space Medicine Overview, and Nutritional Biochemistry for Space Flight.
- The division has continued tracking the application process for residents and students who are interested in entering our program. The simple Microsoft Excel spreadsheet process begun in 2014 has advanced to an established database using File Maker Pro

developed by Kevin Dunajski from the Boonshoft School of Medicine.

 In 2015, the application review process for residents and MS students was revised and went from a qualitative dictatorial process to a quantitative democratic process. In our overall efforts to improve the quality of residents and students entering our program, we needed to know where each applicant ranked. Grading sheets were developed (one for residents on a 100 point scale, one for M.S. students on a 70 point scale) for application review. Each applicant is now reviewed by three faculty with a final averaged grade being assigned. By doing this, we are able to track where we have been in regard to applicant strength so that we may determine focus areas for future improvement. The process has also transitioned from a dictatorial process involving the PD to a democratic process involving the faculty.

## Flight Medicine Clinic

- Our visit numbers have increased by 56% from 2014 to 2015. This year we have seen 187 pilots and air traffic controllers for physicals and visits.
- The Optec 900 was added to our clinic for additional testing options of color vision deficient pilots. This is in line with our division goal of making our clinic a 'full service' flight medicine clinic. In conjunction with Cog screening and the ability to care for pilots who have substance dependence issues, our clinic is nearly a full service clinic for pilots and Air Traffic Control specialists.
- Dr. Olson and Dr. Jarnot were designated by the FAA as Employee AMEs meaning they are now authorized to perform FAA employee physicals (i.e. for air traffic controllers).
- Both residents and M.S. students have been involved with flight medicine clinic helping to enhance the student's educational experience.

## Scholarly Activities

- WSU ASM sponsored the second annual Stanley R. Mohler Lecture Series presented at the Experimental Aircraft Association AirVenture in Oshkosh, Wisconsin. Some of the topics that were covered include cardiovascular issues in airman certification, sleep apnea and pilot certification, hypoxia, and neurologic issues in airman certification. The lecture series provides six credits of CME for attending physicians and health care providers.
- A certificate course focused on basic aerospace medicine was established in 2015. The course is six months in duration and is scheduled to be launched in 2016. It provides an additional option for students who may not be able to afford full one or two year tuition through our traditional MS program.

## **Collaborative Efforts**

- Dr. Christopher Lienesch, who graduated in 2015, was involved in a collaborative research project with the Oregon Air National Guard and the USAF regarding cervical strain/injury in fighter pilots. The work is scheduled to be published in 2016.
- We have continued in a cooperative agreement with SpecPro Technical Services to provide medical personnel for the 711<sup>th</sup> Human Performance Wing on a contract basis.

- We have become an affiliate member under the University of Texas Medical Branch for collaborative research efforts concerning commercial space flight.
- The division has entered into a collaborative effort along with 16 member universities and 13 affiliate universities to submit an application for a solicitation focused on Air Traffic Controller education and research through the FAA. The application is scheduled to be submitted in 2016.
- The division has been working with the WSU MPH program to provide core curriculum classes for USAF RAM students who are working toward their MPH degree.
- The division continues to provide the MS degree for USAF residents of aerospace medicine. This year we have four RAMs who entered into our program.

## Community Support

- Our division has continued to send job advertisements to interested alumni in an effort to maintain alumni relations and provide continued support.
- We have added an online alumni update form to our website in order to collect contact information so as to maintain communications with our alumni.
- Both Drs. Jarnot and Olson attended and presented aerospace medicine lectures to the Flying Physicians Midwest chapter.

**Center for Global Health (CGH)** mission is to provide education, conduct research, and promote service towards improving and sustaining the health of populations and individuals worldwide.

Educational responsibilities of the Center include the Master of Public Health (MPH) degree program, Certificates in Health Care Management (HCM), Global Health and Emergency Preparedness, the Health Care Management concentration for the Wright State University Master of Business Administration (MBA) program, the Physician Leadership Development Program, Public Health Grand Rounds, and undergraduate medical student coursework in Population Medicine, Quantitative Analysis, and Clinical Prevention. All graduate school coursework offered by the Center is provided at the Research Park campus, and all courses are offered in the evenings. Instruction supporting medical school curriculum takes place at White Hall, and the Public Health Grand Rounds take place at community-based sites and the WSU campus.

The MPH program is the largest single activity of the Center. The program was launched in 2004, and achieved full five-year, unconditional accreditation by the Council on Education in Public Health (CEPH) in 2007. The MPH program was re-accredited in April 2012 for seven years, the longest possible duration. The program is a community-based, interdisciplinary degree with a wide variety of program partners. Academic partners include the WSU College of Education and Human Services, the Raj Soin College of Business, the College of Liberal Arts, the College of Mathematics and Science, and the College of Nursing and Health. Community partners include Public Health Dayton and Montgomery County, as well as several other regional public health districts. The Air Force School of Aerospace Medicine became a partner in the MPH program following its relocation to Wright-Patterson

Air Force Base in 2011. The MPH program offers two concentrations; Health Promotion and Education, and Population Health Management.

The Certificate program in Health Care Management (HCM) was launched in 2003, and provides graduate level courses in health resource management and policy, health care finance, and health care strategic leadership. It was developed as a joint venture involving with Raj Soin College of Business. In 2005, the Certificate Program received the President's Award for Excellence. Students in the WSU MBA program pursuing a concentration in HCM are eligible to enroll in the Certificate program, but are not required to do so. In 2015, the Center launched two new certificate programs, Global Health and Emergency Preparedness.

The Physician Leadership Development Program (PLDP) offers medical students an innovative program through which they can obtain either a Master of Public Health (MPH) or Master of Business Administration (MBA) degree while pursuing their medical degree. The PLDP program emphasizes physician leadership and provides a unique opportunity to integrate medical and graduate studies through a longitudinal clinical experience that all students take during their graduate term.

Center faculty members have been innovators in medical education by lecturing in the areas of population medicine, quantitative analysis, professionalism, and clinical prevention for medical students in the Boonshoft School of Medicine. Faculty made presentations at national, regional, and local meetings. MPH students presented at regional meetings. In addition to teaching and research, faculty members serve the public health community through various partnerships with regional health departments and membership on numerous local community boards and committees. The many culminating experiences and practice placements completed by MPH students led to extensive improvements and enhanced understanding of several public health programs and services in the metropolitan area, the region, nationally and globally. As in previous years, faculty and students volunteered at the annual Celebrating Life and Health fair at Sinclair Community College sponsored by the Levin Family Foundation.

**Center for Healthy Communities (CHC)**, started in 1991, is a community-academic partnership committed to improving the health of the community and enhancing health professions education. In 2011, the CHC merged with the Center for Global Health (CGH) and is now a division within the Center for Global Health.

**Center for Interventions, Treatment, and Addictions Research (CITAR)** represents the focal point for substance abuse related services, academic research, and services research. Two other programs and projects operate within CITAR, Substance Abuse Resources & Disability Issues (SARDI), and Weekend Intervention Program (WIP).

• In 2014, the National Institute on Drug Abuse funded a three-year study to be conducted by researchers in CITAR and Kno.e.sis, entitled, *Trending: Social Media Analysis to Monitor Cannabis and Synthetic Cannabinoid Use,* (R01 DA039454). The overall goal of this study is to develop an innovative software platform, eDrugTrends, that will facilitate

analysis of trends in knowledge, attitudes, and behaviors related to the use of cannabis and synthetic cannabinoids as discussed on Web forums and Twitter.

- In 2014 (2015 No-Cost extension), the National Institute on Drug Abuse funded a oneyear study, entitled, *NIDA National Early Warning System Network (iN<sup>3</sup>): An Innovative Approach.* Funded through the R56 (DA38366) mechanism for high priority projects, iN<sup>3</sup> combines the use of an innovative pair of systems to detect new episodes of drug use. The first involves ToxIC, a nationwide network of medical toxicologists who treat episodes of new drug use at the bedside. The second involves semantic web analyses of social media to identify new drugs of abuse. Knowledge from ToxIC informs the online analyses, while the web semantic approach can help refine the clinical interviews performed by the toxicologists. This interdisciplinary study involves researchers in CITAR, Kno.e.sis, University of Massachusetts Medical School, and the American College of Medical Toxicologists. Resubmission of an R01 extending the study is in preparation.
- In 2008, the National Institute on Drug Abuse funded a five-year natural history study to be conducted by CITAR researchers: *Opioid Use Trajectories and HIV Risk among Young Adults in Ohio*, (Grant # R01DA023577). The overall aim of this study is to describe trajectories of non-prescribed pharmaceutical opioid use and identify the factors associated with the development of DSM-IV abuse or dependence (and transition to heroin use) among young adult users as well as HIV risk behaviors. A final sample consisting of 383 people was recruited. All follow-up interviews through 36 months were completed in 2013. This past year we completed several longitudinal analyses and presented one paper during the Year 2 no-cost extension. Publication of longitudinal studies is on-going.
- *The Dayton Area Drug Survey* (DADS) is a biennial, cross-sectional study that provides estimates of teen drug use in the Miami Valley. First administered in 1990, DADS is a collaborative effort between CITAR and area school districts. The study has been funded entirely by CITAR. Districts choose which grades between seven and twelve they want to survey. Students respond anonymously and on a voluntary basis. DADS data are used by a variety of groups to support applications for funding, research, and for community planning. Since its inception more than 190,000 students have participated in DADS. We are in the process of re-administering the DADS in 2016.
- In 2015, Public Health Dayton & Montgomery County funded CITAR to continue producing the *Montgomery County Poisoning Death Review*. The goal of the study is to collect and analyze reports of unintentional drug overdoses provided by the Montgomery County Coroner's Office. Quarterly reports summarizing the findings are produced and presented to the Montgomery County Opiate Task Force. We hope to renew this study in 2016.

**Substance Abuse Resources and Disability Issues (SARDI) Program** seeks to improve the quality of life for persons with disabilities, including those who are concurrently affected by behavioral health issues. The SARDI Program achieves its objective by conducting collaborative and participatory research, developing intervention approaches and training, and disseminating related information.

New Grants Awarded to SARDI in 2015

- SAMHSA awarded a three-year CSAT grant of \$1.2 million in its Offender Reentry Program to SARDI starting October 2015. This grant will provide funding for Substance Use Disorder treatment, including medication-assisted treatment (MAT) and HIV prevention services, for ex-offenders who do not have health insurance.
- SARDI will collaborate with the Department of Family Medicine to provide evaluation services for its SAMHSA Screening, Brief Intervention, and Referral to Treatment (SBIRT) grant for \$600,000 awarded October 2015. This grant will support faculty from WSU Boonshoft School of Medicine, School of Professional Psychology, School of Nursing, and Health, and the College of Education and Human Services as they develop and provide SBIRT training to health professions students.
- SARDI will provide evaluation services for a SAMHSA Drug Court grant of \$975,000 awarded to the Montgomery County Common Pleas Court. This grant will provide funding for SUD treatment, including medication-assisted treatment (MAT), for offenders sentenced to a specialty court who do not have health insurance.
- SARDI will also provide evaluation services for SAMHSA MHFA grants of \$375,000 awarded to each of three local grantees, East Dayton, Mount Olive Baptist Church, and Mental Health America. These grants are intended to provide Mental Health First Aid training to individuals recruited by the grantees. SARDI staff will collect, manage, and analyze data for these three projects.
- Interact for Health (formerly the Health Foundation of Greater Cincinnati) awarded SARDI a one-year grant of \$15,000 to evaluate a Mindfulness Project funded by Interact for Health. This project will study the effect of yoga and mindfulness training of coping and mental health in veterans with PTSD and the counselors who treat them.
- SARDI was awarded a contract to evaluate a 3-year, \$300,000 grant awarded to the Montgomery County ADAMHS Board by the Bureau of Justice Affairs. This grant will develop a diversion program for the county as well as increase the number of case managers in the County Jail.
- The Montgomery County ADAMHS Board awarded a grant of \$167,000 to SARDI to administer and provide leadership for the Montgomery County Prevention Coalition. This grant will end 12/31/2016.
- SARDI received an extension (3/1/2015 12/31/2015) for \$108,627 for their Second Chance grant from the ADAMHS Board of Montgomery County. The goal of the Second Chance initiative is to improve employment outcomes at the Montgomery County Job Center for those at risk of alcohol and other drug abuse.
- SARDI also received a small grant of \$41,705 (9/1/2015 6/30/2016) from the ADAMHS Board to develop and pilot test of gambling prevention intervention for at-risk youth in Montgomery County.

## **Ongoing Grants**

In 2014, SAMHSA awarded three grants totaling \$2,000,000 to SARDI over a four-year period (9/30/2014 – 9/29/2018), including a CMHS grant for \$917,200, a CSAT grant for \$298,200, and a CSAP grant for \$784,600. These grants will support the Intensive Continuum-of-Care Services (ICS) Project, which will provide AOD/HIV prevention services to youth and adults and provide co-located treatment of substance use disorders, mental health disorders, and HIV at CAM.

- In 2014, SARDI received a five-year (10/1/2014 9/30/2019) NIDRR DRRP grant of \$2,449,934 to translate and validate eight widely used assessment instruments into American Sign Language (ASL). These instruments, once validated, will be made available online for free, and their use by VR counselors will be monitored and analyzed.
- In 2014, SARDI also received a NIDRR FIP grant of \$599,977 for a period of three years (10/1/2014 - 9/30/2017) to investigate the use of web portals and online VR services by counselors who are trained by SARDI staff to use these services.
- Interact for Health (formerly the Health Foundation of Greater Cincinnati) awarded a grant of \$57,611 to SARDI to conduct process and outcome evaluations for their Mental Health First Aid Project (6/1/2014 – 6/1/2015). This grant was extended until June 30, 2016, for an additional \$38,078.
- SARDI continued a 5-year (2013-2018) grant from Ohio MHAS for \$415,000 to conduct GPRA training and provide GPRA data management for their SAMHSA SBIRT Cooperative Agreement.
- With the Department of Family Medicine, SARDI co-authored an NIDA grant proposal to develop text messaging services for patients at risk for AOD abuse at Five Rivers Health Center. They were awarded \$22,000 in June 2014. SARDI continued to assist with technology and evaluation for this project, which ended in May 2015.
- SARDI received a contract in December 2015 for \$3,000 from Montgomery County to provide evaluation services for their Peacemaking Circles intervention for women in reentry.
- A three-year (2012-2015) Health Foundation of Greater Cincinnati grant, "SARDI Evaluation Services for the Health Foundation of Greater Cincinnati Mental Health/Medical Integration Project", for \$392,008, was ongoing in 2015. SARDI will be upgrading the evaluation services for the grantees in the Health Foundation's Mental Health/Medical Integration Project.
- The e-CAM project augmented traditional face-to-face SUD treatment by providing personal web pages for CAM consumers that permit consumer access to their personal health records and other web-based health information. A three-year (2011 – 2014) SAMHSA/ Center for Substance Abuse Treatment (CSAT) grant for \$839,937 supports this project, which was extended until February 28, 2015.
- The "Fifty-Plus Prevention Project" was funded by a five-year (2010 2015) SAMHSA/ CSAP grant for \$1,087,281, and includes group and environmental-level interventions to reduce substance abuse and HIV risk among African Americans age 50 and older in Montgomery County. In the final report submitted December 2015, we reported that 389 received the *Shield HIV* intervention, 2,037 received HIV testing and counseling, and 1,520 received the *Community Promise* environmental intervention.
- Another 5-year (2010 2015) SAMHSA/CSAP- funded project (for \$1,149,208) called "Substance, Testing and Education Program Using Prevention (Step-Up)" provided prevention interventions to reduce substance abuse and HIV risk among at-risk college students in Greene County, specifically at Wright State, Central State, and Wilberforce Universities. In the final report submitted in December 2015, we reported that the Step-Up project served 368 students with a group-level intervention at these universities to date and conducted HIV testing and counseling for 2,379 and environmental prevention strategies for 3,732 students.

- In 2015, SARDI received \$5,000 from the Dayton Tennis Association and \$1,000 from the Midwest Tennis Association to support the Tennis ACES program for youth that incorporates an adapted version of SARDI's PALS drug prevention program.
- The SARDI Consumer Advocacy Model (CAM), which offered mental health and SUD treatment services at the downtown Dayton office as well as its satellite office in Urbana (Champaign County), was transferred from SARDI to Samaritan Behavioral Health, Inc., in February 2015.

**Weekend Intervention Program (WIP)** for impaired drivers is a component of an interdisciplinary effort linking the area's courts and substance abuse treatment agencies. In operation since 1978, WIP provides a comprehensive assessment of an individual's involvement with alcohol and other psychoactive drugs, confronts participant denial, encourages self-evaluation, increases accessibility to treatment, and prepares participants for treatment when necessary. WIP continues to provide opportunities for medical student, graduate student, and undergraduate student education.

- In 2015, 1,189 clients completed the Weekend Intervention Program, compared to 1,173 in 2014. The referrals include individuals from 70 different courts in at least 20 different counties throughout Ohio.
- The 8-hour Youth Education Program (YEP!) is an alternative sentencing option for young adults who have experienced a non-driving alcohol- or drug-related arrest. The target population of underage offenders (age 18-21) is provided with information about the harmful effects of alcohol and other drugs and the high risk associated with continued underage use. They also have the opportunity to self-evaluate their current involvement with alcohol or other substance use. In 2015, 237 individuals completed the YEP!, compared to 268 in 2014.
- The 8-hour Short Term Education Program (STEP) is an alternative sentencing option for offenders whose offense the court has determined does not warrant the 72-hour residential program. 16 individuals completed the STEP in 2015.
- In 2015, 27 medical students participated in the *Weekend Intervention Program* service learning elective to broaden their knowledge of substance use disorders. During their weekend, students gain valuable experience working with patients who have substance use disorders as they conduct drug and alcohol screens and assessments, brief motivational interventions, and substance abuse education for the individuals participating in the program.
- Four doctoral-level students from the School of Professional Psychology participated in the *Weekend Intervention Program* as a component of their coursework in 2015. In addition, 31 undergraduate students participated in WIP while completing the Drug and Alcohol Intervention Workshop sociology course offering, and 68 undergraduate students participated in the YEP! while completing the Intensive Alcohol Education sociology course offering.

**Lifespan Health Research Center (LHRC)** conducts ongoing research projects, and is home to the Fels Longitudinal Study. The Fels Longitudinal Study which began in 1929 is the world's longest running study of human development, growth, body composition, and aging.

Research in the Lifespan Health Research Center focuses on examining risk factors and health consequences for a number of common diseases, including obesity, cardiovascular disease, sarcopenia, osteoporosis, and functional decline with aging. Researchers are interested in examining these questions using an approach that examines health and disease across the lifespan. These studies include investigations of normal childhood growth and development, as well as studies of normal aging and chronic disease risk.

The Center also administers undergraduate and pre-graduate student educational research training. Funded by the National Institutes of Health, the STREAMS (Short-Term Training Program to Increase Diversity in Health-Related Research) encourages members of underrepresented minority groups and students with disabilities to choose careers in cardiovascular-related research by providing short-term research internships.

**Division of Medical Humanities,** is comprised of one full-time faculty member, Mary White, PhD, assisted by numerous voluntary faculty from the Boonshoft School of Medicine, the Center for Global Health, and the Dayton medical community. In 2015, ethics curricula was offered in three B1 courses: *Physician, Patient, and Society* (8 hours), ICM (2 hours) and Neuroscience (2 hours). In addition, Dr. White teaches the first year global health elective: *Health Care in Developing Countries* and coordinates the online course *Nutrition in Medicine*. In B2, Dr. White leads ethics conferences in four third-year clerkships (1-4 hours each), and debriefs two simulated patient encounters involving difficult conversations. She also offers electives for fourth-years: *Future Directions in Global Health* and *Literature and Medicine*, participates in a new elective on translational research, and regularly advises three to four fourth-year student initiated electives. In addition to her medical school teaching, she teaches *Public Health Ethics and Policy* in the MPH program, and has been working with the Departments of Religion, Philosophy, and Classics to develop a Medical Humanities minor for undergraduates.

Dr. White's research activities in 2015 included one publication on teaching end-of-life communication, co-authored with faculty from the Department of Surgery, and one article in press on "Musical activity as it contributes to quality of life," (International Journal of Community Music). She developed a proposal (accepted) to teach ethics to the Public Health Department of Dayton and Montgomery County (to be implemented in 2016). She presented at meetings of the Academy for Professionalism in Health Care in Louisville, Kentucky; The International Conference to Promote Resilience, Empathy, and Well-Being in the Health Professions, and the American Society of Bioethics and Humanities. Her community service includes serving on the Children's Medical Center Institutional Review Board, the Kettering Health Network Ethics Committee, Hospice of Dayton's Ethics Committee, the Dayton Area Ethics Consortium, and projects with Welcome Dayton and Catholic Social Services on immigrant services. She is currently Board President of the American Fund for Charities.

**Reach Out of Montgomery County's** mission is to provide access to healthcare services for the underserved/uninsured population in Montgomery County, without restraints, utilizing the professional skills of volunteer physicians, nurses, pharmacist, translators and other health care professionals.

Reach Out clinics began in 1995, funded in part by an award from the Robert Wood Johnson Foundation to begin the county's first free clinic for the uninsured by family physicians. In 2015, Reach Out gained more insight on how the Affordable Care Act is impacting those with insurance as well as those uninsured and ineligible for Medicaid insurance. The cost of care has risen and with it came alterations to insurance plans such as limited medication formularies and higher deductibles. We have seen access issues, cost issues, transportation and translation issues on the rise. Reach Out will continue to serve those who find the Affordable Care Act market plans unaffordable, those not qualified for health plans and those in transition due to various reasons such as moving from county to county or state to state. Our building is expanding to accommodate training for patients as well as volunteers. Decision making in the new healthcare environment now requires a team, a solid communication system (Electronic Medical Record) and continuous learning to stav within a balance of best practices and cost of care. We have a busy year ahead of us as we collaborate on several new projects, community paramedic, case management, and collaborations with grants to stimulate this regions innovation approaches to care. Our partnerships remains strong with local hospitals and corporations and we hope our charity contributions will grow as the public becomes more aware of the barriers in our current healthcare system. Our CORE mission continues to focus on access issues as we face challenges with medical professional shortages. Medical Students are invaluable on the frontline assisting this vulnerable population in Dayton, Ohio bringing institutions and faculty together to work for the common good. This mission brings about cooperation and collaboration among business competitors. On a small budget Reach Out has made great strides in providing access to care for those who otherwise may be without.

The Department of Community Health is also affiliated with **Premier Community Health**. Premier Community Health is part of Premier Health Partners and serves the community with programs focused on prevention, early detection, and self-management education around heart, cancer, diabetes, and lung health. It provides mammograms and Pap tests to uninsured and under-insured (working poor) women over 40 in nine counties. It also provides free and low cost heart risk assessments, colorectal cancer kits, diabetes education and hemoglobin A1C's, tobacco cessation counseling and more.
