# 1 Statement from the Chair

Faculty and staff of the education center offer the Master of Public Health degree along with six certificate programs. Fifty-one students, including six dual degree students (MD/MPH), enrolled during the 2018-2019 academic year. The program generated 1,082 graduate credit hours and graduated 26 MPH students. Drs. Redko and Khalil also offered online undergraduate general education classes in global health and climate change. These classes generated 3,617 credit hours and are part of the department's plan to increase student awareness of public health disciplines and careers. The education center team also prepared for an October 2019 Council on Education for Public Health (CEPH) accreditation site visit; the team updated several courses and submitted a preliminary self-study document in May.

The two department research and evaluation centers conducted work related to substance use, behavioral health, and disabilities. The faculty and staff of these centers operated 19 multi-year grants totaling over \$14.2 million dollars. The Substance Abuse Resources and Disability Issues' (SARDI) funders include Substance Abuse and Mental Health Services Administration (SAMSHA); National Institute on Disability, Independent Living, and Rehabilitation Research; Ohio Department of Mental Health and Addiction Services; and several local service contracts. The work of Center for Interventions, Treatment, and Addictions Research (CITAR) is funded by the National Institutes of Health, National Institute on Drug Abuse. The research teams made 19 national, state, and local presentations. A third independently funded research center, Fels Longitudinal Study, was transferred this year to the University of Texas School of Public Health under the direction of former department faculty Drs. Stefan Czerwinski and Miryoung Lee.

Looking forward, the vision of the department is to be recognized as the leader of population and public health initiatives within the university and across southwest Ohio. To achieve this vision, the department has started to operate in a more collaborative manner, where the expertise across the centers creates opportunities for learners and adds community value. Goals for the upcoming year include recruit and mentor new faculty, expand public health education programs, identify emerging public health career pathways, and expand the amount and type of department research.
