Statement from the Chair

This year, the department moved forward on many important initiatives; most notably, the department relocated to 2555 University Blvd, within the same building as the departments of Emergency Medicine, Geriatrics, and Psychiatry. The relocation increases our visibility with students and improves opportunities for interdepartmental collaborations. Please stop by and tour the new classroom and student lounge!

Academics - Enrollment in the academic public health programs continues to grow. Fifty-one M.P.H. students enrolled during the academic year, and the program graduated 25 students. The graduating cohort included four public health employees, three medical school students, seven USAF physicians, plus a variety of wonderful professionals from various fields. We recognized their excellence in epidemiology, health promotion and education, public health spirit, and more.

We also celebrated the graduation of 23 undergraduate students. These students shared exciting plans for their future, including continuing their education in professional preparation programs. We are excited to welcome three of these scholars into our M.P.H. program eager to learn more about diverse career opportunities in local and state public health.

Given the landscape of public health, our faculty are energized to explore ways to increase engagement in our programs and support the rebuilding of our local public health workforce. The team has added several new undergraduate courses and partnered with Raj Soin College of Business to offer a new graduate Leadership and Ethics course. At our annual retreat, the group brainstormed ways to raise awareness about the profession, build bridges between the undergraduate, graduate, and alumni base, and engage students in more service learning. We expect great things in 2023-24.

Scholarship and Giving - The department also continued to prioritize increasing the number of students who receive a scholarship, with 27% of the graduate students receiving some tuition support. The Boonshoft Public Health Workforce Scholarship, which provides tuition assistance to public health employees, has awarded eleven scholarships since the program's inception in 2020. In addition, faculty and alumni generously participated in our second alumni giving campaign – Wright Day to Give - which successfully endowed the Master of Public Health Student Scholarship founded by our former colleague Mr. Ken Dahms.

Research - The faculty and staff of the department's research centers continued their work in substance use, behavioral health, and disabilities. The research teams directed 12 grants totaling over \$2.7 million in annual expenses, published 15 peer-reviewed articles, and made 22 national, state, and local presentations. Three faculty - Wilson, Ford, and Kinzeler- were recognized for their Excellence in Grantsmanship, with other faculty working hard to join this elite club!

Looking forward, the department continues to focus on two strategic initiatives – to grow enrollment and opportunities in undergraduate public health education and rebuild the funded work of the Center for Treatment, Interventions, and Research. These initiatives build upon strengths in the department, our public health expertise, and a 30+ year history of extramurally-funded substance use research.
