## Statement from the Chair/Associate Dean

Wright State University Boonshoft School of Medicine has a well-established Family Medicine department with 24 Full Time faculty members including faculty involved in predoctoral medical education, graduate medical education, research, and clinical care which will be increasing to twenty-six with two new Faculty Members starting in second half of 2023. In addition, the Department has 4 Nurse Practitioners who participate in Medical Student Education. This Department has been a cornerstone of the medical school since its inception in 1973. In the past three years, faculty have received multiple awards from the BSOM (Innovation in Teaching, Mentorship, Medical Education), Wright State University (Presidential Award for Faculty Excellence: Early Career and International Education Award), and the Ohio Academy of Family Practice (Educator of the Year). Members of the department have leadership roles at the medical school level (recent Associate Dean for Student Affairs and Admissions, recent Interim Associate Dean for Academic Affairs, and current Associate Dean for Research), the state level (recent President of the OAFP), and national level (recent past president of the AAFP). This year Dr. Paul Hershberger received the Academy of Medicine Senior Faculty Award and Dr. Jennifer Lee received the 2023 Innovation in Medical Student Education Award.

The faculty practice on the campus of WSU is growing and provides Student Health Services for the University. We have dedicated and accomplished faculty members and have outstanding programs in multiple areas across the clinical, education and research missions. Faculty members are continually active in predoctoral medical education, including clinical medicine skills training, the third year Family Medicine clerkship, and eleven electives for third- and fourth-year students. The Department has strengths in Global Medicine, Addiction Medicine, and Sports Medicine.

The Division of Medical Education under the leadership of Dr. Kate Conway is thriving. There are numerous Family Medicine Courses, rotations, and pathways for Medical Students in addition to POCUS, Global Health, Public Health, and Healer's Art Electives. Global Health Scholars program is becoming immensely popular with Medical Students, and more than a quarter of the medical students are choosing to participate in this program. The Family Medicine department has been a leader in the development and implementation of point-of-care ultrasound (POCUS) into the BSOM student education and experience through case discussions, annual and FM clerkship workshops, and a POCUS elective. Dr. Jennifer Lee has been instrumental in this initiative. We were fortunate to be participants at the Ohio Academy of Family Physicians' first POCUS workshop and we continue to make strides in the implementation of POCUS education into the WSU Family Medicine Residency. There is a strong global health refugee care clinic at Five Rivers Family Health Center that was established with the support of a PCORI Grant in 2017 to support community engagement and clinical services for refugees.

The Wright State Family Medicine Residency Program is the result of the merger between Miami Valley Hospital's program and the Dayton Family Medicine Residency at Good Samaritan in 2009. It is now a 30-trainee program (10/10/10) led by Dr. Pete Reynolds, and is based at the Five Rivers Family Health Center, a Federally Qualified Health Center five miles north of downtown Dayton. This residency program, first accredited in 1972, celebrated its 50th year of continuous operation last year and had a 100% board passage rate last year. The Wright State University Family Medicine Residency Program attracts strong students from Wright State and the wider United States. Many graduating residents practice locally. Faculty and residents lead at the local, state, and national level. Recent graduate Nicole Turkson, M.D., Ph.D., has returned as faculty. Paul Hershberger, Ph.D., director of behavioral science, was awarded a SAMHSA grant for training medical students, residents, and other health professionals about SBIRT (Screening, Brief Intervention, and Referral to Treatment), an evidence-based practice used to identify, reduce, and prevent problematic use, abuse and dependence on alcohol and illicit drugs. The Department also launched a chapter of The Ladder, a progressive mentoring program, focused on children with an interest in health careers who live in the neighborhood around the residency clinic at Five Rivers Family Health Center. The residency also has a longitudinal wellness and resiliency training that includes "Tending the Flame" during the R2 year which is like the "Healer's Art" for medical students.

Another highlight this year is the new Rural Residency Program in Darke County, Greenville Rural Family Medicine Residency program, which is a separately accredited 1+2 Rural Training Pathway with 3 residents in each PGY year under the leadership of Dr. Carlos Menendez. The department established rural clerkship locations and a rural residency track near the WSU Lake Campus. This effort was funded by the Health Path Foundation. The rural residency had a 100% successful match this year.

The Department also received accreditation for a new Addiction Medicine Fellowship this year under the leadership of Dr. Anna Squibb and they are recruiting their first Fellowship Candidate starting July 2024.

Regarding Research, the department collaborates with multiple other departments both within the BSOM and outside it. Multiple manuscripts and poster presentations with DFM faculty authors have been published or accepted for publication this academic year, with BSOM student involvement on nearly all. The department has secured a five-year Health Services Research Administration (HRSA) training grant Program: **Augmenting Resident Training for Needs in the Emotional Realm** (PARTNER) and the Principal Investigators are Drs. Reynolds and Hershberger. This grant is from 12/31/2022 to 9/29/2027 and the total 5-year award is \$2,281,497.

The other grants were HRSA RRPD Grant for development of the Wright State University Family Medicine Rural Residency Program (\$ 750,000), Wright LIFE (Lifelike Immersion for Equity) Ohio Department of Medicaid (\$ 539,030), Refugee Healthcare (\$72,200), Wright OUTT (Opioid Use Treatment Training) Program SAMHSA/PCSS-U (\$735,000) and Wright MAT SAMHSA/PCSS-U (\$449,957).

Regarding Clinical Services, the academic year 2022-2023 was a challenging one for all aspects of departmental activities, especially clinical care in midst of change in leadership in February 2023. Due to critical staffing shortages and staff turnover related to COVID pandemic, the Department of Family Medicine changed its clinical care model and cut down the potential visits offered to patients to nearly half and closed the practice to new patients in July 2022. It led to decreasing revenue and loss of patients starting July 2022 until the slow and progressive course correction started in January 2023. The total net revenue from Wright State Physicians Family Medicine office/ In Patient Service / Wright State Family Medicine Residency Program/ Student Health from July 1, 2022, to June 30, 2023 was \$3,135,19. Many new initiatives such as Huddle Board, development of standard work, panel management, accelerated scheduling, EMR In box management, different scribe options and Team-based care are expected to transform this practice to a high functioning excellent clinical practice with high satisfaction ratings from patients, staff and providers. We are in the process of developing more specialized clinics such as Integrative Pain Management Clinic and Functional Medicine Clinics in anticipation of developing Lifestyle Medicine and Integrative Medicine Fellowships in the coming years. We are looking forward to a significantly improved clinical service model in this academic year.
