Statement from the Chair

During the 2022-2023 academic year, the Department of Geriatrics successfully advanced our academic and professional activities and continued our strong support of the tripartite mission of the Boonshoft School of Medicine (BSOM) in primary care education, clinical research, and achieving excellence in health care services in southwestern Ohio. We also continued our strong commitment as a department and as part of the BSOM to serve our community through tangible activities and partnerships.

During this past academic year, our department maintained a culture of “we” with each departmental member responsible to the group for our successes, with the Department of Geriatrics

- Educating a significant number of medical students, resident physicians and fellows.
- Disseminating geriatric information and best practices to practicing health care providers;
- Producing scholarship in aging, aging policy, and healthcare delivery as it pertains to older adults.
- Providing model older adult clinical services; and
- Participating in older adult community activities.

We met all our educational and clinical commitments this past academic year with 7 core departmental faculty in Geriatrics and Hospice and Palliative Medicine (HPM), consisting of 3 university based and 4 based at the Dayton Veterans Administration Medical Center (Dayton VAMC).

The department had 2 HPM fellows this past academic year, with one hired to help as a second attending with our Miami Valley Palliative Care Teaching Service, as well as establish a new relationship with Dayton Childrens as a part-time palliative care physician. We also had 2 Geriatric Medicine Fellows and were able to hire one to replace Dr Steve Swedlund in our ambulatory care clinic, as he retired at the end of this June his 2023. With his retirement, I assume the role of Geriatric Program Director for the foreseeable future until a suitable candidate is hired. I have promoted Dr Robin Rinehart to the HPM Fellowship Director as of July 1, 2023. We are fortunate to have 2 HPM fellows and 1 Geriatric Medicine Fellow this next year.

The third position for a long-term care Geriatrician will be placed in the budget for the next academic year and will be one of our highest priorities, as we seek to recruit a Geriatrician to staff a second teaching nursing home. A second teaching nursing home is a very much needed departmental expansion to provide a larger setting for Family Medicine resident teaching and expansion of our student clerkship.

While the above-mentioned recruitments will be a great benefit for maintaining the department’s educational mission, we also need experienced academicians to join us, particularly as I plan my succession and for the successful growth and stability of the department over the next two years. As recently discussed with my Dean, the search for my successor will begin this next academic year. I plan to retire at the end of December 2024 and will remain the Geriatric Fellowship Program Director and a faculty member, if a new Chair is identified prior to that time.

4 Teaching

Undergraduate medical education

The department provided a contribution to the SOM's WrightCurriculum through both didactic presentations and Wright Q small group facilitation in Years 1 and 2, as well as several interprofessional sessions. Our contribution to the Foundations curriculum was mainly through the efforts of Lindsay Benedik, PharmD, in which she in part provided the perspective of an older adult health provider, including her teaching in the following modules:

- Origins (6 sessions).
- Host & Defense (8 sessions).
- Staying Alive (18 sessions) – including development of an independent study on aging
- Beginning to End (15 sessions) - also module director.
- Balance, Control, Repair (1 session)
- Interprofessional education events (2 sessions)

The department also provided specific older adult and end-of-life care curricular didactic and clinical activities in Years 3 and 4. We provided direct clinical training to both Year 3 and 4 clinical students continuously throughout the academic year. Our clinical clerkship efforts included providing:

- 8 Year 4 Students a comprehensive 2-week Palliative Medicine Elective experience
- 4 Year 4 students a comprehensive 4-week Geriatric Medicine Elective experience
- 68 Year 3 students a 2-week Year 3 clerkship in Geriatrics and Palliative Care. This clerkship will become a 4-week Year 3 clerkship in 2024 or 2025, depending on our growth of preceptors and ongoing discussions with the Office of Medical Education and Faculty Curriculum Committee.

Graduate medical education

- *Geriatric Medicine Fellowship*
 - Further refined the fellowship portfolio of core curriculum topics and materials.
 - Continued in Year 5 of our 10-year program self-study.
 - Successfully trained 2 fellows and recruited 1 fellow for the 2023-2024 academic year.
- *Hospice and Palliative Care (HPM) Fellowship*
 - Further refined the fellowship portfolio of core curriculum topics and materials.
 - Enhanced the clinical experiences in palliative care in the hospital and home settings; as well as more robust hospice clinical experiences in the inpatient and home settings
 - Enhanced the milestone model for the progress of the fellows in their year of training.
 - Enhanced the system of evaluation and feedback to the fellows; including a more structured format on a quarterly basis.
 - Enhanced the education on our MVH inpatient palliative care teaching service.
 - Enhanced our home hospice rotation with Vitas Hospice
 - Maintained a relationship with Hospice of Dayton for a strong rotation in acute inpatient hospice.
 - Continued in Year 5 of our 10-year program self-study.
 - Trained 2 fellows and successfully recruited 2 fellows for the 2023-2024 academic year.
- *IM Residency*
 - Initiated more robust clinical experiences in palliative care, hospice, post-acute and long-term care medicine at the Dayton VAMC and MVH with greater focus on the individual and specialty needs of each resident.

- Successfully completed the long-needed redefining the Year 3 rotation as a Year 2 rotation and to include more structure and specific skills and milestones to be achieved in Geriatrics and Palliative Medicine by the resident physicians during their 4-week rotation.
- Trained 48 Internal Medicine resident physicians in palliative care, geriatrics and post-acute and long-term care medicine in 2022-2023, as we started our transition from a Year 3 rotation to an all Year 2 rotation in 2023-2024.

- *FM Residency*
- Refined the residency portfolio of core curriculum topics and materials for our three residency rotations: Year 2-3 Longitudinal Rotation in Long Term Care Medicine, Year 2 four-week rotation in Skilled and Palliative Care, and Year 3 four-week rotation in Ambulatory Care Geriatrics
- Further enhanced the Year 2 four-week rotation in Geriatrics to be a much stronger Skilled and Palliative Care Rotation
- Further enhanced the Year 3 four-week rotation in Geriatrics to be a stronger rotation in Ambulatory Primary Care Geriatrics and Geriatric Assessment
- Further enhanced the Geriatric content in their Family Medicine Residency Core Curriculum to 24 topics over 18 months to include improved topics in both Geriatrics and Palliative Care
- Trained 28 Family Medicine resident physicians in post-acute and long-term medicine, palliative care, ambulatory primary and specialty geriatrics through 3 permanent rotations and the Family Medicine Residency Core Curriculum.

7 Patient Care Summary

The department stabilized the financial status of its' clinical activities, as follows:

- Maintained the level of our onsite post-acute and long-term care clinical activities, while maintaining an active teaching practice at one area nursing home after our second one was sold to a propriety entity and did not desire to remain a teaching nursing home.
- Maintained the level of home care clinical activities in the range of 400 to 420 patients, with our number of NPs downsized from 4 to 3.
- Shifted departmental emphasis away from ambulatory care except for educational purposes and have replaced our retired physician with a new graduate geriatrician with a clearer version to see greater patients in a half day as of August 2023.
- Our teaching service at Miami Valley Hospital for Palliative Care Consultations, which has achieved educational success, is requiring significant ongoing and careful financial assessment due to the amount of foundation support it has required.
