# **STATEMENT FROM THE CHAIR**



The past year was one of productivity and growth in the Department of Psychiatry. There were significant contributions to peer-reviewed literature and increased external grant funding in a wide variety of areas of psychiatry and neuroscience. Our faculty members act as ambassadors for the Boonshoft School of Medicine through their dozens of local, regional, statewide, national, and international Plenary Sessions, presentations, and posters. They are also active in service on Editorial Boards, Advisory Boards, and Committees, both within the University, throughout the state, and at the national and international levels. Our patient care priorities include addiction, intellectual disability, child/adolescent psychiatry, and the public sector. Our goals of training future psychiatrists who provide evidence-based patient care while serving our community remain strong. Our commitment to address the addiction epidemic in our community has been transformed to touch the lives of many through numerous clinical, educational, scholarly, and community integration initiatives.

Dr. Kari Harper was named the Division Director of the Child/Adolescent Psychiatry (CAP) Fellowship this year; Dr. Ryan Mast was named the Director of Medical Student Mental Health Services. Funding was identified for all civilian adult psychiatry residents and the CAP Fellows utilized Dayton Children's Hospital and various community agencies. We successfully identified space and funding to expand the training program on the civilian side to match our military complement. Our department division leaders created a strategic plan with 1- and 5-year goals (each with designated faculty leads). We successfully recruited and hired additional psychiatrists, Dr. John Sullenbarger and Dr. Larrilyn Grant, who will support both the training program and the research initiative, among other educational endeavors.

The Department is on the cutting edge of technology with extensive use of Telepsychiatry services to reach rural and under-served communities with over 2,400 patients with complex needs from 87 of the 88 counties engaged across the state of Ohio. Wright State continues to be the home base for Ohio's Coordinating Center of Excellence in Mental Illness/Intellectual Disability and Ohio's Telepsychiatry Project. We continue to receive extensive funding support from the Ohio Department of Mental Health and Addiction Services as well as the Ohio Department of Developmental Disabilities for numerous clinical, scholarly, and educational initiatives. We also use technology for MCAT training and consultation in collaboration with the Ohio Department of Developmental Disabilities, which has an expanding statewide following.

We enjoy increased levels of support from Wright Patterson Air Force Base, the Veterans Administration Medical Center, Premier Health, and Kettering Health Network. Our BSoM medical students pursue psychiatry at rates double the national average thanks to the leadership of Dr. Bethany Harper and Dr. Nita Bhatt. Our scholarly work has expanded significantly due to the leadership of Dr. Danielle Gainer. Dr. Otto Dueno offers an Interventional Psychiatry rotation for BSoM medical students.

Our collaborative efforts with other departments in the BSoM, WSU campus, and the Dayton community (and well beyond!) continue to expand and promise to strengthen the program. We are committed to continued excellence in the areas of clinical, educational, and scholarly programs; we will continue to be integrated into our community and to serve others regarding mental illness and mental wellness.

Dr. Kari Harper was named Division Director of Child/Adolescent Psychiatry. Funding was identified for all civilian adult psychiatry residents and the CAP Fellows utilizing community hospitals and agencies. We successfully identified space and funding to expand the training program on the civilian side to match our military complement. Our department division leaders created a strategic plan with 1- and 5-year goals (each with designated faculty leads). We successfully recruited and hired an additional psychiatrists, Dr. Larrilyn Grant and Dr. John Sullenbarger, who will support both the training program and the research initiatives. New goals and a new formal strategic plan are under development.

### **Child and Adolescent Psychiatry Fellowship**

*Kari Harper, M.D.: Director, Child and Adolescent Psychiatry Fellowship*

The Child and Adolescent Psychiatry Fellowship serves to meet the needs of the children and adolescents of our community by providing outstanding clinical care at a variety of sites including: Dayton Children's Hospital (inpatient, consult-liaison, and outpatient psychiatry), Access Ohio (providing telepsychiatry to children, adolescents, and adults who have Intellectual Disability), Five Rivers (working in Integrated Care Clinics with Pediatrics and Family Medicine), Daybreak (serving the needs of housing insecure and runaway youth in the community), Wright State University (college mental health), Wright State Resident Psychotherapy Clinic (brief and long term dynamic, play, trauma-informed, and cognitive-behavioral therapies), and the Wright Patterson Air Force Base (outpatient psychiatry for military families). In addition, it is the mission of the division of Child and Adolescent Psychiatry to train Fellows, Residents, and medical students through a didactic curriculum and through supervision of clinical cases in both medication management and psychotherapy.

### **Rural Psychiatry**

*Danielle Gainer, MD; Director, Rural Psychiatry*

The Rural Psychiatry Division exposes psychiatry residents to patients from rural communities throughout the state of Ohio via telehealth. Ohio's Telepsychiatry Project has provided comprehensive psychiatric care to over 2,300 patients with complex mental health needs from 87 counties in Ohio. This project serves patients with co-occurring mental illness and intellectual disability and provides greater access to psychiatric care to patients in rural communities. During the 2022-2023 academic year, twenty-four psychiatrists (nine faculty members and fifteen residents) improved access to care by providing treatment to these patients.

## **Research Division**

*Danielle Gainer, MD; Director, Research Division*

During the 2022-2023 academic year, the Research Division within the Department of Psychiatry conducted a variety of scholarly projects. Scholar's Forum continued to occur approximately bimonthly and provided opportunities for collaboration, feedback, and discussion. Dr. Danielle Gainer and Dr. Sydney Silverstein, along with other members of their research team, concluded a mixed methods research study related to race and gender disparities in post-overdose trajectories.

A group of psychiatry residents and medical students, led by Drs. Jeffrey Lewis and Jessica Steinfeld, continued to work on a systematic review related to cognitive factors predictive of substance use treatment outcomes. This same team is actively recruiting participants to a prospective study at OneFifteen to obtain effect size measurements of cognitive measures that may be predictive of treatment retention. A group of medical students also conducted a retrospective record review from the Ohio Telepsychiatry Project and presented the findings at a variety of local, state and national psychiatric conferences. Lastly, the research division is also actively working on creating an online resource for students/residents to use for commonly asked research-related questions.

## **Medical Student Mental Health Services**

*Ryan Mast, DO; Director, Medical Student Mental Health Services*

The Medical Student Mental Health Services Division provides access to mental health care that is free-of-charge (regardless of insurance status) to the medical students of WSU BSOM. Medical students nationally traverse a challenging educational path, and some will seek out mental health services for: support, informal mentorship, formal testing, and/or treatment for specific symptoms (eg. insomnia, anxiety, etc). Our services are primarily provided by Julie Gillespie (Licensed Professional Counselor) and Ryan Mast, DO (Psychiatrist), and these services include: individual therapy, couple's therapy, group therapy, psychological testing, and psychiatric medication management. Treatment options include in-person and/or virtual sessions to best meet the needs of the students. The division also provides students with information on how to access other services (including off-campus resources if they wish to use their insurance to see an off-campus provider).

## **Mental Illness / Intellectual Disabilities**

Gentile MD, MBA: Director, Division of Intellectual Disability Psychiatry; Project Director, Ohio Coordinating Center of Excellence (CCOE) in Mental Illness/Intellectual Disability (MI/ID) and Ohio's Telepsychiatry Project in MI/ID. Co-Investigators: Allison Cowan MD, Danielle Gainer MD, Bethany Harper MD, Kari Harper MD*

The Division oversees two statewide, grant funded projects serving patients with co-occurring mental illness and intellectual disability. The Coordinating Center of Excellence provides community team development, statewide Second Opinion Assessments, and educational programming. Ohio's Telepsychiatry Project provides comprehensive mental health treatment to over 2,300 patients with complex needs from 87 of the 88 counties in Ohio. The Division has been awarded more than \$11 million since inception.

## Community Psychiatry

*Brian M. Merrill M.D., M.B.A. Director of the Division of Community Psychiatry*

This division oversees PGY-III residents during their yearlong community psychiatry rotation and PGY-IV residents during their half-year-long rotation in Addiction Medicine. The emphasis during these rotations is on the development of evidence-based diagnostic and therapeutic skills needed to provide excellent clinical care for people experiencing severe and persistent mental illness (SPMI) and/or substance use disorders. Residents are exposed to best-practice service delivery models like Assertive Community Treatment (ACT) and novel programs like First-Episode Psychosis. PGY-III residents attend a monthly didactic series focusing on a range of topics meant to augment their clinical experience. We have systems-based topics, clinical presentations, and we visit sites in the field that provide psychosocial, supportive, and clinical services to help understand the network of community resources available to our patients. The Division Director hosted two DATA-2000 training courses prior to the elimination of the DATA 2000 requirement for buprenorphine prescription. The DATA-2000 trainings were delivered to medical students, internal medicine PGY-I's and psychiatry PGY-I's. Though the DATA 2000 requirement was waived in January of 2023, the Division Director continues to provide Addiction Medicine training in collaboration with colleagues through a SAMHSA grant, which provides support to WSUBSOM faculty to update Addiction Medicine curriculum at all levels of the school of medicine and in the community. For the GME trainees, the trainings allowed for earlier exposure to addiction medicine and community psychiatry content compared to previous orientation curricula.

## Addiction Psychiatry

*Brian M. Merrill M.D., M.B.A. Director of the Division of Addiction Psychiatry*

Our community was identified as one of the "ground zero" locations in the nation for opioid use deaths and high prevalence of Substance Use Disorders. Over the past four years Dr. Merrill served as Assistant Medical Director for OneFifteen, a tech-enabled ecosystem dedicated to the full and sustained recovery for individuals experiencing substance use disorder. Dr. Merrill's professional relationship with OneFifteen ended in June of 2023 and he will be collaborating with an Athens, Ohio based organization called Integrated Services for Behavioral Health. Through this relationship there will be opportunities for collaboration with the 22 counties in SE Ohio where ISBH operates, though also ISBH is considering expansion into the Dayton area. An Addiction Medicine fellowship has been successfully accredited through the Family Medicine department and is being led by Dr. Anna Squibb. The Addiction Medicine Division has been actively working with an ongoing SAMHSA grant wherein support is provided to faculty to revamp education curricula across UME, GME, and with relevant WSU (e.g. NP program, nursing program, School of Professional Psychology, etc.) and community entities (University of Dayton PA program, etc.). Due to recent closures in relevant community partners (e.g. OneFifteen) there is a current shortage of community sites for R4 Addiction Medicine at this time. The Division developed a rotation at the Dayton Veterans Administration Hospital this year and continues to communicate with other potential partners. The R4 Addiction Medicine rotation, when clinical sites are not available, is being used to augment the SAMHSA grant and many of the Psychiatry Residents are getting supervised experiences by Drs. Merrill and Gainer in Clinician Educator rotations.



## Psychotherapy Clinic

*Associate Training Director of Psychotherapy and Clinic-Based Services*

The WSU Department of Psychiatry Residency Psychotherapy Clinic continues to provide high-quality, low-cost psychotherapy in person and via telehealth to the greater Dayton area and has done so for over 25 years. The clinic provides individual couples, marital, and family therapy in many evidenced-based modalities. Additionally, the clinic conducts play therapy and individual therapy to children and adolescents both via telehealth and in-person. In order to meet the needs of our patients, the clinic continues to offer both telehealth and in-person visits. The psychotherapy clinic also provides mental health services to the Wright State University medical students including individual and couples therapy. Our clinic continues to expand and now serves as a training site for a total of 39 psychiatry residents and child and adolescent psychiatry fellows. In addition to our clinic remaining the recruiting gem for residency applicants that it has been for many years, it serves as a touchstone for over 35 faculty across the country who remain invested in psychiatry and psychotherapy education in the Wright State University Department of Psychiatry Psychotherapy Clinic.

## Medical Student Education

*Bethany Harper, MD*

*Director of Medical Student Education for the Department of Psychiatry*

*Nita Bhatt, MD, MPH*

*Associate Clerkship Director*

The division oversees the educational activities of medical students at Wright State University Boonshoft School of Medicine during all four years of the curriculum. This includes the Foundations Phase and the Doctoring Phase. The Foundations phase consists of years 1 and 2 and Doctoring phase consists of the Doctoring year and the Advanced Doctoring year. During Foundations, the mental status exam is introduced to the first-year medical students during their Introduction to Clinical Medicine course. The introduction to psychiatry course is an integrated course with neurology and musculoskeletal/integument content titled Balance, Control, and Repair (BCR) during the second year of medical school. BCR is facilitated by the Psychiatry Faculty, Neurology Faculty, Dermatology Faculty, Pathology Faculty, and Pharmacy Faculty. Dr. Harper acts as co-module director and a total of three psychiatry faculty members participated as Peer Instruction facilitators and team-based learning facilitators. During Doctoring and Advanced Doctoring, third- and fourth-year medical students rotate through the psychiatry clerkship and fourth year psychiatry electives, respectively.

The Psychiatry Clerkship continued as a separate clerkship with a pass/fail/honors grading system. The length of the clerkship continued at four weeks in length. Dr. Harper works with other faculty on development of psychiatry related content within the new curriculum—The Wright Curriculum. During the 2022/2023 Academic Year, which started April 2022, Dr. Sara Cruikshank and Dr. Michael Ji were appointed Education Chiefs. For the 2023/2024 Academic Year, Dr. Michael Hubbell, Dr. Genevieve Miller, and Dr. Basir Hussaini were appointed Education Chiefs. During the 2022/2023 Academic Year, Dr. Bhatt, the second-year child fellows, and the fourth-year Education Chief Residents assisted as facilitators during team-based learning sessions and other interactive sessions for the Psychiatry Clerkship. The formal curricular time in the Psychiatry Clerkship is over 80% Active Learning based, with TBL/PBL curriculum. The inpatient faculty and Chief Residents complete formative evaluations of

observing students interviewing patients. Additionally, the faculty and residents generally spend 1-2 hours a week in formal teaching time with the students in addition to the clinical teaching.

We have four inpatient sites (MVH, VAMC, KBMC, and Twin Valley Behavioral Health in Columbus) with one to three attending preceptors at each of those sites. Four to six students now do a combination of inpatient psychiatry and consultation/liaison psychiatry at the Premier site (MVH) with three to four students rotating on inpatient psychiatry and one to two students rotating on consultation/liaison psychiatry at MVH; one to two students rotate on inpatient psychiatry at the VA with one of those students spending time on the consultation/liaison service at the VA and one of those students spending time in the outpatient setting at the VA; two students rotate on inpatient psychiatry at KBMC; and two to three students rotate on inpatient psychiatry at Twin Valley Behavioral Health in Columbus.

In person participation was emphasized. New patient intakes at 2555 are encouraged to be in-person. Didactics for residents will be required in-person starting July 1st 23-24 AY in line with other local and national residency program standards.
  - WPAFB, the Dayton VA Medical Center, Access Ohio and the DD clinic continued telepsychiatry and in-person treatment
- Resident Funding:
  - Department of Defense
    - Continues to fully fund US Air Force residents within the program
  - Premier Health— new leadership is increasing funding for residents after several years of decreased funding

- Graduation returned to having in-person attendance

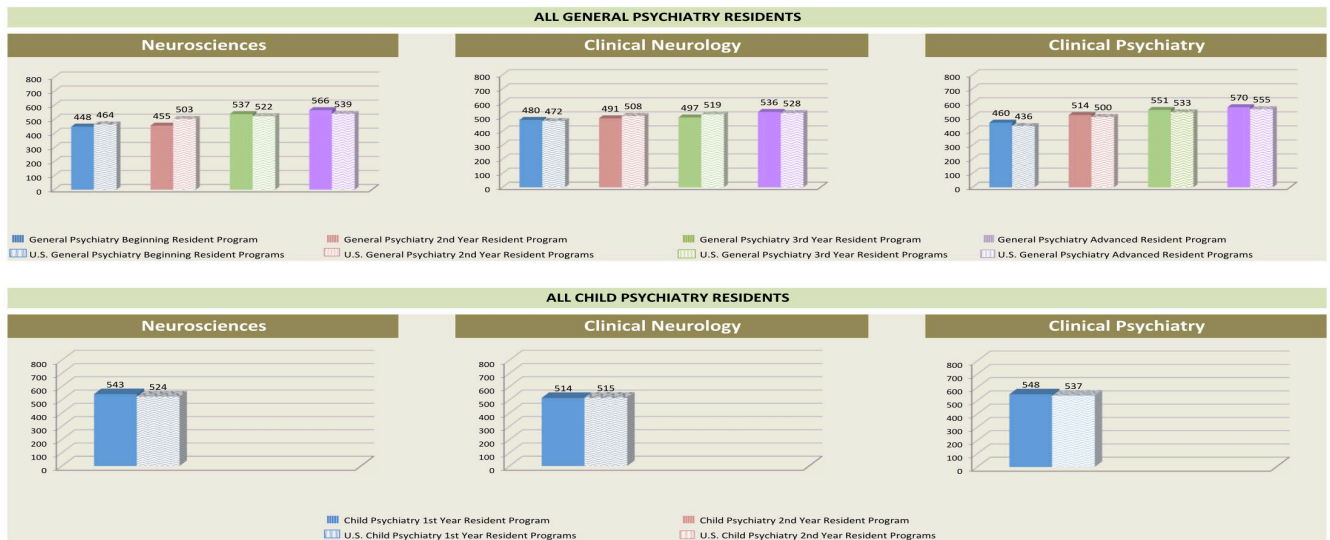

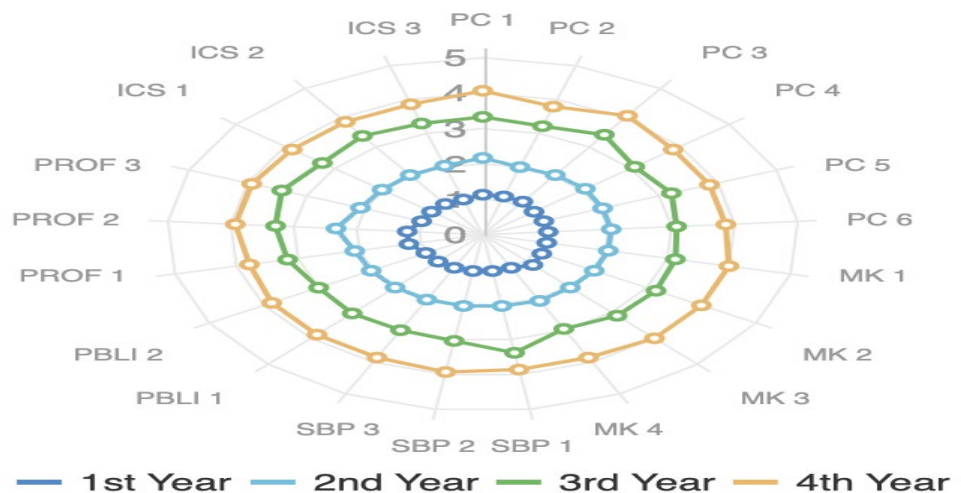

teaching. Additionally, there is work being done with the local community hospital to expand working space for learners which is limited and potentially contributing to dissatisfaction with impact of other learners on resident education.

- Faculty members discuss cost awareness in patient care decisions - there are plans to more directly address this during PGY-3 community didactics and emphasize the need for supervisors to have verbal discussions regarding cost:benefit analysis during medical decision making. There is also consideration to have a departmental grand rounds with open discussion on cost awareness in medical decision making.
- Patient Safety & Teamwork
  - Participate in safety event investigation and analysis - there is currently a root cause analysis process in place for patient safety events several times throughout the year in order to involve residents in safety event investigation and analysis. There are plans to increase resident participation in this process by improving frequency and clarity of communication regarding this and other current opportunities.
- Faculty Survey
  - In past, have talked about process for reporting unprofessional behavior and ensure there is a process in place at each clinical site
- Satisfaction with process for evaluation as educators
  - In past, talked about action plan for proper evaluations to be distributed to proper learners and educators.
  - Conducting professional development activity on providing feedback to learners for our faculty members (August 2023)

# SCHOLARLY ACTIVITY

To increase scholarly activity among faculty and residents, we created a Scholar's Forum. This involves meetings to elicit research ideas and interests, negotiate difficulties in initiating research, and develop research oriented working groups. Our national regard and reputation were enhanced through presentations at numerous national meetings including the American Psychiatric Association, and American Association of Child and Adolescent Psychiatry, the National Association for the Dually Diagnosed, and the American Association of Directors of Psychiatric Residency Training. Faculty members have been active on Editorial Boards, Advisory Boards, and committees, both within the University, throughout the local community, and at the national level. Dr. Allison Cowan and Dr. Julie Gentile serve as editors of a peer-reviewed monthly column in a highly respected journal, *Clinical Innovations of Neuroscience*, for Psychotherapy Rounds. There was an increase of 300% in the published works over the past 3 years, initiation of multiple research projects (including planning stages of our first clinical trial) and numerous grants (now totaling more than \$11,000,000 since 2003) in many areas of psychiatry and neuroscience.

New sites include an addiction clinic for adolescents and transition age adults at Daybreak, which is also a training site for adult residents CAP Fellows. We also have placed (and funded) a resident at the MonDay Program, providing addiction and SPMI treatment attached to the correctional system.

The Resident Therapy Clinic continues to be a unique community resource and serves not only patients from the community but also students from the BSoM. The focus on dynamic psychotherapy as an evidence-based practice continues to be one of our strongest recruiting tools for graduating medical students. The clinic provides more than 3,900 hours of therapy for patients in our community this year and has a flat fee of \$40 per session and is fiscally stable for the first time in decades.

The Department retains its cutting-edge use of Telepsychiatry services to reach rural and under-served communities across the state; this project was implemented in 2011. We are now serving 2,300 of the most complex patients from 87 of Ohio's 88 counties and collaborating with multiple agencies to offer integrated treatment programs. We continue to receive funding support from the Ohio Department of Mental Health and Addiction Services as well as the Ohio Department of Developmental Disabilities (totaling nearly \$11 million since inception).

Dr. Julie Gentile, Dr. Allison Cowan and Dr. Kari Harper have partnered with DODD and OCALI to create the first IDD Multi-system Consultation Teleconference, which is a weekly real time consult across the state of Ohio for youth ages 10-18 years of age.
