Statement from the Chair

2015 continued to be a successful year for the Department of Emergency Medicine. From a scholarship standpoint, the faculty and residents were quite productive. Led by the efforts of Drs. Marco and Olson, we produced multiple book chapters and articles. In addition, Dr. Marco's book on Ethics in Emergency Medicine was published. Several poster and oral presentations were also made.

The Department remained active in service, both to medicine and the community. We remain active in 5 EDs throughout town: MVH, GSH, CMC, WPAFB, and Sycamore. We anticipate adding MVH South and Good Samaritan North experiences in the near future. A significant portion (probably 1/3) of the patients in those departments is seen by our faculty and/or residents. In addition, all the medical support for Tactical Teams in the region is provided by Department of EM faculty and residents. We remain the medical providers for several federal teams and provide medical direction and support for the State Highway Patrol. Our CAP lab experience, led by Dr. Pickett and run by the residents, remains the premier EMS educational experience in the region.

Our tradition of educational excellence in emergency medicine continues. The residency training program is one of the oldest and largest in the country. Our graduates provide quality emergency care throughout the country and as far away as New Zealand. We educate every 4<sup>th</sup> year medical student in EM during their required clerkship. We interact with 1<sup>st</sup> and second year students in both didactic experiences and with simulations experiences throughout the second year. We are now training both WSU and KCMA senior nursing students in the simulation lab. Other students from across the region have some to spend time in our simulation center.

We continue to educate and serve the Miami Valley community, providing leadership in Emergency Medicine.


